

**LAKE OF THE WOODS ASSOCIATION, INC.**

**MARINA & LAKE AGREEMENT FOR WATERCRAFT REGISTRATION**

1. Applicant must be the owner of the watercraft and be a member of Lake of the Woods Association, Inc. (LOWA) in good standing or a tenant in good standing.
2. This application is made with the agreement of the undersigned that the undersigned will keep said watercraft in good repair and working order, and there is no duty on the part of LOWA, Inc. to inspect same. The undersigned agrees to hold Lake of the Woods Association harmless against any and all claims, loss, damage, attorney fees, cost or other expenses incurred by Lake of the Woods Association in connection with said watercraft for which this application is made.
3. Issuance of a registration to operate a watercraft is made subject to the conditions and regulations governing the operation of a watercraft on the waters within LOWA, which are now, or may hereafter be, promulgated by the Lake of the Woods Association, Inc. Such conditions and regulations, together with conditions set forth below, are made a part of this application.
4. In consideration of the issuance of a registration for the operation of a watercraft on the waters within Lake of the Woods as requested in this application, it is understood and agreed that such watercraft shall not be used for rental or ferry purposes, or the transportation of any person, persons, or material for hire or for any commercial purpose. It shall only be operated for the personal and private use of the applicant, his or her family, and for reasonable accommodations to his or her personal guests.
5. It is agreed that the undersigned fully understands and will comply with all Federal, State and County regulations, laws, and/or ordinances and all instructions and rules, as outlined in the LOWA, Inc. Regulations governing "Use of the Lakes" issued in conjunction with watercraft registration. It is further understood and agreed that L.O.W. Security and Commonwealth of Virginia officials may periodically cause the watercraft to be stopped for safety equipment checks. It is also understood that neither LOWA, Inc. nor the Commonwealth of Virginia is obliged to conduct such a check of the watercraft or the equipment therein.
6. It is understood and agreed that no vested right of the operation of a watercraft at Lake of the Woods accrues through the issuance of said registration.
7. It is understood and agreed that a violation of any of the foregoing conditions and regulations controlling the operation of a watercraft within Lake of the Woods which are now, or may hereafter be, promulgated by the management of the Lake of the Woods, Association may result in a **summons** to appear before the Legal and Compliance Committee (LCC) and may result in revocation of this registration.
8. The undersigned acknowledges receipt of a copy of the Lake of the Woods Regulations pertaining to "Use of the Lakes".
